Q What does "Tax Compliance" mean?

A "Tax Compliance" means fulfilling your obligations for; income tax, capital gains tax, fringe benefits tax, superannuation guarantee and any other federal or state tax. The tax office has many ways of detecting non compliance and they are continually finding new methods. These include; benchmarking, data matching, unexplained wealth and their biggest source is "dabbers", usually family members, disgruntled employees and ex-spouses. When they detect or suspect non compliance they may estimate the tax payable and send a bill including fines and penalties. The severity of the fine or penalty is generally determined by the intent of the taxpayer, or non-taxpayer in this case. Was the non-compliance an honest mistake or was there an intention to defraud the Commonwealth. It's a bit like a homicide, was it accidental manslaughter or was it premeditated murder. Honest mistakes may incur no penalties at all, whereas fraud is a criminal offence and may incur jail time. So what can we do to comply? Keeping good records is essential and if errors are found then make voluntary disclosures to the tax office, they are now more amicable than ever before, but also most intuitive and able to detect non compliance.

In this case we can remove the drive and put it into a new external caddy to get it working again. In some cases through the actual drive is faulty and the data may not be able to be retrieved. 

Q How do I put eye-drops in my eyes?

A Have you tried to put in eye-drops and found that they run down your cheek instead of remaining in your eye? Here are some tips to prevent this happening, giving your medication the best chance to effectively manage or treat your condition. When using eye-drops, tilt your head back slightly and look into a mirror. Use your index finger to gently pull down your lower eyelid, which will create a pocket for the drop. Release a drop into this pocket and gently close your eye. Press your index finger on the inside corner of your closed eye for about one minute to prevent the medication escaping down your tear duct. It is important that you do not touch the nozzle of the bottle to your eye as this can transfer bacteria to the container.

Q What are the consequences of tooth loss?

A With the loss of teeth the residual ridge no longer benefits from the functional stimulus it once experienced. Due to this a loss of ridge volume can be expected. This will occur in both height and width. This is not accurately predictable for patients with variable results occurring. Generally bone loss is greater in the mandible than the maxilla, more pronounced posteriorly than anteriorly, and it produces a broader mandibular arch while constricting the maxillary arch. Associated with this bone loss is the alteration of the oral mucosa, which is more readily traumatized. With the loss of teeth and diminishing residual ridge, facial features can change, secondary to altered lip support and reduced facial height as a result of reduced vertical dimension.
